Conditions of Eligibility

To be considered for eligibility for the Future Engineers Scholarship, a student must:

- Be a full-time student at the time of application submittal, pursuing a degree at an accredited institution of higher education in the United States, or Canada, during the 2014 calendar year, and be accepted into the School of Engineering.
- Have a college cumulative grade point average (GPA) of 3.0 or higher on a 4.0 scale (or 3.5 on a 4.5 scale, and so forth).
- Scholarships will not be awarded to 1st year undergraduate students or those 4th year undergraduate students, who will be graduating on or before June 2014.
- Be an United States or Canadian citizen, a resident alien/ landed immigrant; be in good legal standing with their university if on a student visa, or in the case of candidates from American Samoa or the Commonwealth of the Mariana Islands, a United States national. Submissions must include a letter reflecting the candidate's intent to obtain employment in the field of engineering in the United States or Canada.
