- 31,000 shares were sold at an average price of \$24.7456 per share. Forty-two individual trades were executed at prices ranging from \$24.51 per share to \$24.85 per share.
- 17,415 shares were sold at an average price of \$24.4316 per share. Sixty-seven individual trades were executed at prices ranging from \$24.08 per share to \$24.78 per share.
