- 10,505 shares were sold at an average price of \$14.946 per share. Thirty one individual trades were executed at prices ranging from \$14.66 per share to \$15.11 per share.
- 31,734 shares were sold at an average price of \$15.0338 per share. Twenty six individual trades were executed at prices ranging from \$14.87 per share to \$15.11 per share.
